## **General Description**

Supports the Facilities Supervisor and Property Manager with cleaning and preparing residential and commercial properties through general maintenance and repairs.

**Essential Duties and Responsibilities** include the following. Other duties may be assigned.

- 1. Responsible for completion of all maintenance service requests as assigned for specific property(ies)
- 2. Performs tasks associated with electrical, plumbing, carpentry, masonry and painting.
- 3. Assists Property Manager with repairs and treating structures such as showers, sinks, appliances, doors, cabinets, walls and building exteriors.
- 4. Performs minor maintenance tasks.
- 5. Assists with maintenance of grounds to include trash pick-up, sweeping sidewalks, shoveling, and landscaping.
- 6. Gets units ready for new move-ins.
- 7. Ensures safety practices are followed in compliance with all company, local, city, state, and federal guidelines.
- 8. Responds to work orders as assigned.
- 9. Follows Buckingham policies and procedures and complies with Fair Housing, state, and federal laws.
- 10. Responsible for early morning and/or weekend shoveling, during snowy season.
- 11. Performs other special projects and other job related responsibilities as assigned.

## **Minimum Qualifications**

- 2 year's experience in general property maintenance
- High School Diploma or GED
- Valid and clean driver's license to be able to get to necessary job locations (with personal vehicle)
- OSHA 10 hour course a plus

## **Physical Demands**
